BAC RESOLUTION

RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO D'LUXE WATER REFILLING FOR THE PROCUREMENT OF PURIFIED WATER FOR THE REGIONAL OFFICE FOR FEBRUARY TO DECEMBER C.Y. 2024

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **PURIFIED WATER FOR THE REGIONAL OFFICE FOR FEBRUARY TO DECEMBER C.Y. 2024**;

WHEREAS, the Approved Budget for the Contract (ABC) is **FIFTY-TWO THOUSAND EIGHT HUNDRED PESOS (Php52,800.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on January 11, 2024 to January 16, 2024 at 9:00 a.m.;

WHEREAS, RFQs were sent to at least three (3) prospective suppliers as follows: (1) D'Luxe Water Refilling Station; (2) Aqualife Water Refilling Station; and (3) MCDC Water Refilling Station;

WHEREAS, one (1) Supplier submitted its proposal; **D'LUXE WATER REFILLING** in the amount of **FIFTY-TWO THOUSAND EIGHT HUNDRED PESOS (Php52,800.00)**. Thus, **D'LUXE WATER REFILLING** is declared as the lone bidder;

WHEREAS, after review and deliberation on the proposal, **D'LUXE WATER REFILLING** complied with the requirements and declared as the Single Calculated and Responsive Bid (SCRB);

NOW, THEREFORE, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **D'LUXE WATER REFILLING** in the amount **FIFTY-TWO THOUSAND EIGHT HUNDRED PESOS (Php52,800.00)**.




