RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO SUNNY GLADES PROPERTIES CORPORATION (TAGAYTAY HAVEN - MENDEZ) FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE REVISION OF THE 4TH BATCH STORYBOOK FOR KINDERGARTEN TO GRADE 4, 5 AND 6 LEARNERS FOR THE NATIONAL READING PROGRAM SUPPLEMENTARY READING MATERIALS

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of FOOD AND ACCOMMODATION for the REVISION OF THE 4TH BATCH STORYBOOK FOR KINDERGARTEN TO GRADE 4, 5 AND 6 LEARNERS FOR THE NATIONAL READING PROGRAM SUPPLEMENTARY READING MATERIALS on DECEMBER 4-8, 2023;

WHEREAS, the Approved Budget for the Contract (ABC) is THREE HUNDRED THOUSAND PESOS (Php300,000.00);

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Phillippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on November 22, 2023 to November 28, 2023 at 9:00 a.m.;

WHEREAS, RFQs were sent to five (5) prospective suppliers as follows: (1) Tagaytay Country Hotel; (2) Splendido Tagaytay Hotel; (3) Days hotel Tagaytay; (4) Hotel Kimberly Tagaytay; and (5) Escala Tagaytay;

WHEREAS, three (3) suppliers submitted their respective proposals before the deadline for the submission of bids, offering the following financial bids, as read:
