

MHGAP TRAINING FOR DEPED MEDICAL OFFICERS AND NURSES

To **Schools Division Superintendents**

1. Relative to the letter of invitation from the Department of Health IVA-CALABARZON¹, this Office, through the Education Support Services Division - School Health and Nutrition Unit will participate in this Training on February 12-16, 2024, at Ramada by Wyndham Central, Ongpin St., cor. Quintin Paredes St., Binondo, Manila.
2. We recognize the need for an inclusive and integrated approach to address the growing concerns with mental health issues. Hence, this training aims to:
 - a. equip non-specialized healthcare workers with the necessary knowledge and skills to identify personnel and learners with mental health conditions;
 - b. promote basic mental health services in the DepEd schools and workplaces;
 - c. enhance pre-service training with the MHGAP-IG and contribute to a learning environment that nurtures knowledge and skills required to help people with mental health needs.
