WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of CATERING SERVICES for the ADMINISTRATIVE SERVICES DIVISION QUARTERLY DIVISION PROCESS REVIEW on MARCH 21-22, 2024, JUNE 6-7, 2024, AUGUST 29-30, 2024 AND NOVEMBER 28-29, 2024;

WHEREAS, the Approved Budget for the Contract (ABC) is ONE HUNDRED FIVE THOUSAND SIX HUNDRED PESOS (Php105,600.00);

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on February 6, 2024 to February 12, 2024 at 9:00 a.m.;

WHEREAS, RFQs were sent to at least three (3) prospective suppliers as follows: (1) GOD'S TREASURE ENTERPRISES; (2) FOCAL MANAGING LOOP INC.; and (3) MEYER'S FOOD AND SERVICES, INC.;

WHEREAS, two (2) suppliers submitted their respective proposals before the deadline for the submission of bids, offering the following financial bids, as read:
