**BAC RESOLUTION**

**RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO JPFES FIRE EXTINGUISHER TRADING FOR THE PROCUREMENT OF REFILLING OF RELC-NEAP FIRE EXTINGUISHER**

**WHEREAS**, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **REFILLING OF RELC-NEAP FIRE EXTINGUISHER**;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **TWENTY-FIVE THOUSAND SEVEN HUNDRED PESOS (Php25,700.00)**;

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS**, the Request for Quotation (RFQ) was posted in the office website and conspicuous bulletin board in the premises of this Office starting on January 24, 2024 to January 30, 2024 at 9:00 a.m.;

**WHEREAS**, RFQs were sent to at least three (3) prospective suppliers as follows: (1) DACRISDEEK ENTERPRISES; (2) JPFES FIRE EXTINGUISHER TRADING; and (3) RJMANILA CONSUMER GOODS TRADING;

**WHEREAS**, two (2) suppliers submitted their respective proposals before the deadline for the submission of bids, offering the following financial bids, as read:

**WHEREAS**, after review and deliberation on the proposal, **JPFES FIRE EXTINGUISHER TRADING** complied with the requirements and is hereby declared as the Lowest Calculated and Responsive Bid (LCRB);

**NOW, THEREFORE**, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **JPFES FIRE EXTINGUISHER TRADING** in the amount **EIGHTEEN THOUSAND FOUR HUNDRED EIGHTY PESOS (Php18,480.00)**.




