

**CONDUCT OF RANDOM MONITORING OF SCHOOLS ON
CHILD PROTECTION COMMITTEE FUNCTIONALITY**

To: **Schools Division Superintendents**

1. In reference to Unnumbered Memorandum OUOPS 2023 dated March 14, 2023¹, this Office through the Field Technical Assistance Division will conduct random monitoring of public and private schools on Child Protection Committee (CPC) Functionality from March 12-15, 2024, and March 19-22, 2024. The list of monitoring officials and the schedule is attached herewith.
2. The activity aims to provide technical assistance, ensure establishment of CPCs in schools, and assess the functionality of the CPCs in the following areas:
 - a. Organization and coordination
 - b. Policies and Guidelines
 - c. Capacities and Resources
 - d. Service Delivery and
 - e. Accountability and Performance
3. The monitoring team in this activity from the Regional Office are the FTAD personnel while in the Schools Division Office are the Chief of SGOD, M and E Focal Person, and the Learner Rights and Protection Focal person.
4. The monitoring team from the Regional Office will select one (1) school from the elementary, one (1) school from the Junior High School and one (1) school from the Senior High School. 
