Pursuant to DepEd Order (DO) No. 49, s. 2021 entitled *Revised Guidelines on the Grant of Financial Assistance to Private Madaris Adopting K to 12 Basic Education Curriculum*, the financial assistance shall be strictly utilized solely for the school operation and enhancement of teaching and learning.

Specifically, eighty percent (80%) of the said assistance is intended for the salary of the K to 12 teachers while twenty percent (20%) shall be used for the improvement of the school facilities, printing and delivery of Self-Learning Modules (SLM), and payment for teachers' registration and transportation expenses to DepEd-sponsored trainings within the nearby division/region, subject to the usual government accounting and auditing rules and regulations.
