BAC RESOLUTION

RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT TO NADI INTERNATIONAL CORPORATION FOR THE PROCUREMENT OF ONE (1) UNIT PASSENGER VAN FOR THE NATIONAL EDUCATORS ACADEMY OF THE PHILIPPINES, DEPED IV-A CALABARZON (ROIVA-24-02)

WHEREAS, on February 7, 2023, DepEd Regional Office IV-A CALABARZON has advertised its procurement activity for the ONE (1) UNIT PASSENGER VAN FOR THE NATIONAL EDUCATORS ACADEMY OF THE PHILIPPINES, DEPED IV-A CALABARZON (ROIVA-24-02) in the PhilGEPS website, office website, and in conspicuous bulletin board of the Office;

WHEREAS, the Approved Budget for the Contract (ABC) is TWO MILLION PESOS (Php2,000,000.00);

WHEREAS, one (1) bidder submitted its sealed bid at the Regional Office;

WHEREAS, using the checklist of required documents and taking into account the non-discretionary "Pass or Fail Criterion", the BAC found that the lone bidder, NADI INTERNATIONAL CORPORATION, is eligible for being compliant with the required documents. Thus, NADI INTERNATIONAL CORPORATION was rated as "Passed".

WHEREAS, per Abstract of Bids, NADI INTERNATIONAL CORPORATION has the Single Calculated Bid (SCB) with a total amount of ONE MILLION NINE HUNDRED EIGHTY-EIGHT THOUSAND SIXTY-FIVE PESOS AND 53/100 (Php1,988,065.53);

WHEREAS, upon Post-Qualification and careful examination, validation and verification of all the eligibility, legal, technical, and financial requirements submitted by **NADI INTERNATIONAL CORPORATION,** being the Single Calculated Bidder, the latter has been found to be responsive;

NOW, THEREFORE, the BAC hereby RESOLVED:

- 1. To DECLARE NADI INTERNATIONAL CORPORATION as the Single Calculated and Responsive Bidder in the amount of ONE MILLION NINE HUNDRED EIGHTY-EIGHT THOUSAND SIXTY-FIVE PESOS AND 53/100 (Php1,988,065.53); and
- 2. **To RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the **award of contract to NADI INTERNATIONAL CORPORATION** for the Procurement of One (1) Unit Passenger Van for the National Educators Academy of the Philippines, DepEd IV-A CALABARZON (ROIVA-24-02).
