BATANGAS FOR THE CONFERENCE FOR THE HARMONIZATION OF THE LEARNER RIGHTS AND PROTECTION OFFICE AND LEGAL UNIT IN THE REGIONAL AND DIVISION LEVEL

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of CATERING SERVICES AT NEAP-RELC, MALVAR, BATANGAS for the CONFERENCE FOR THE HARMONIZATION OF THE LEARNER RIGHTS AND PROTECTION OFFICE AND LEGAL UNIT IN THE REGIONAL AND DIVISION LEVEL on MARCH 25-26, 2024;

WHEREAS, the Approved Budget for the Contract (ABC) is ONE HUNDRED TWENTY-EIGHT THOUSAND SIX HUNDRED FIFTY PESOS (Php128,650.00):

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Prourement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on March 11, 2024 to March 15, 2024 at 9:00 a.m.;

WHEREAS, RFQs were sent to at least three (3) prospective suppliers as follows: (1) Louie and Chit Restaurant and Event Center; (2) Jhulians Catering; and (3) Gerly's Catering:

WHEREAS, one (1) Supplier submitted its proposal; LOUIE AND CHIT RESTAURANT AND EVENT CENTER in the amount of ONE HUNDRED SIXTEEN THOUSAND TWO HUNDRED PESOS (Php116,200.00). Thus, LOUIE AND CHIT RESTAURANT AND EVENT CENTER is declared as the lone bidder;

WHEREAS, after review and deliberation on the proposal, LOUIE AND CHIT RESTAURANT AND EVENT CENTER complied with the requirements and declared as the Single Calculated and Responsive Quotation (SCRO);

NOW, THEREFORE, the BAC hereby RESOLVES as it hereby RESOLVED to RECOMMEND to the Regional Director, as the Head of the Procuring Entity, the award of the project to LOUIE AND CHIT RESTAURANT AND EVENT CENTER in
