FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE EXECUTING EXCELLENCE: A HOLISTIC APPROACH TO PROGRAM IMPLEMENTATION, MONITORING & ASSESSMENT IN ESSD PROGRAMS, PROJECTS, AND ACTIVITIES (PPAs)

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of FOOD AND ACCOMMODATION for the EXECUTING EXCELLENCE: A HOLISTIC APPROACH TO PROGRAM IMPLEMENTATION, MONITORING & ASSESSMENT IN ESSD PROGRAMS, PROJECTS, AND ACTIVITIES (PPAs) on FEBRUARY 20-23, 2024;

WHEREAS, the Approved Budget for the Contract (ABC) is THREE HUNDRED FORTY THOUSAND PESOS (Php340,000.00);

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Phillippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on February 1, 2024 to February 6, 2024 at 9:00 a.m.;

WHEREAS, RFQs were sent to at least three (3) prospective suppliers as follows: (1) Sunny Glades Properties Corporation (Tagaytay Haven); (2) Tagaytay Automart Inc. (Tagaytay Country Hotel); and (3) Hotel Kimberly Tagaytay;

WHEREAS, three (3) suppliers submitted their respective proposals before the deadline for the submission of bids, offering the following financial bids, as read:
