## **BAC RESOLUTION**

RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO FOCAL MANAGING LOOP, INC. FOR THE PROCUREMENT OF CATERING SERVICES FOR THE CONDUCT OF THE REGIONAL ACCREDITATION FOR DEPED OFFICIATING OFFICIALS

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of CATERING SERVICES for the CONDUCT OF THE REGIONAL ACCREDITATION FOR DEPED OFFICIATING OFFICIALS on MARCH 15-16, 2024;

WHEREAS, the Approved Budget for the Contract (ABC) is THREE HUNDRED TWENTY-TWO THOUSAND PESOS (Php322,000.00);

**WHEREAS,** Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS**, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on March 1, 2024 to March 6, 2024 at 9:00 a.m.;

**WHEREAS,** RFQs were sent to three (3) prospective suppliers as follows: (1) FOCAL MANAGING LOOP INC.; (2)DepEd Region IV-A CALABARZON Multipurpose Cooperative; and (3) GOD'S TREASURE ENTERPRISES;

**WHEREAS**, two (2) suppliers submitted their respective proposals before the deadline for the submission of bids, offering the following financial bids, as read:
