RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO DEPED REGION IV-A CALABARZON MULTIPURPOSE COOPERATIVE FOR THE PROCUREMENT OF CATERING SERVICES FOR THE OPTIMIZING WORKFLOW JUNCTIONS: NAVIGATING THE PROCESS INTERFACE CUM DIVISION PROCESS REVIEW

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **CATERING SERVICES** for the **OPTIMIZING WORKFLOW JUNCTIONS: NAVIGATING THE PROCESS INTERFACE CUM DIVISION PROCESS REVIEW** on **MARCH 25-27, 2024**;

WHEREAS, the Approved Budget for the Contract (ABC) is **FIFTY-FOUR THOUSAND PESOS (Php54,000.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPs), office website and conspicuous bulletin board in the premises of this Office starting on March 4, 2024 to March 8, 2024 at 9:00 a.m.;

WHEREAS, RFQs were sent to at least three (3) prospective suppliers as follows: (1) GOD'S TREASURE ENTERPRISES; (2) FOCAL MANAGING LOOP INC.; and (3) MEYER'S FOOD AND SERVICES, INC.;

WHEREAS, one (1) Supplier submitted its proposal: **DEPED REGION IV-A CALABARZON MULTIPURPOSE COOPERATIVE** in the amount of **FORTY-NINE THOUSAND FOUR HUNDRED FIFTY PESOS (Php49,450.00)**. Thus, **DEPED REGION IV-A CALABARZON MULTIPURPOSE COOPERATIVE** is declared as the lone bidder;

WHEREAS, after review and deliberation on the proposal, **DEPED REGION IV-A CALABARZON MULTIPURPOSE COOPERATIVE** complied with the requirements and declared as the Single Calculated and Responsive Quotation (SCRQ);

NOW, THEREFORE, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **DEPED REGION IV-A CALABARZON MULTIPURPOSE**


