**BAC RESOLUTION**

**RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO LOUIE AND CHIT RESTAURANT AND EVENT CENTER FOR THE PROCUREMENT OF CATERING SERVICES AT NEAP-RELC, MALVAR, BATANGAS FOR THE DIVISION ROLL-OUT OF INSTRUCTIONAL LEADERSHIP TRAINING (ILT): STRENGTHENING LEARNING CONDITIONS FOR EARLY LITERACY**

**WHEREAS**, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **CATERING SERVICES AT NEAP-RELC, MALVAR, BATANGAS** for the **DIVISION ROLL-OUT OF INSTRUCTIONAL LEADERSHIP TRAINING (ILT): STRENGTHENING LEARNING CONDITIONS FOR EARLY LITERACY** on **MAY 6-10, 2024**;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **TWO HUNDRED SEVENTY THOUSAND PESOS (Php270,000.00)**;

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS**, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on March 19, 2024 to March 25, 2024 at 9:00 a.m.;

**WHEREAS**, RFQs were sent to four (4) prospective suppliers as follows: (1) Louie and Chit Restaurant and Event Center; (2) Jhulians Catering; (3) Gerly's Catering; and (4) M.I. Sevilla Catering;

**WHEREAS**, one (1) Supplier submitted its proposal; **LOUIE AND CHIT RESTAURANT AND EVENT CENTER** in the amount of **TWO HUNDRED FORTY THOUSAND PESOS (Php240,000.00)**. Thus, **LOUIE AND CHIT RESTAURANT AND EVENT CENTER** is declared as the lone bidder;

**WHEREAS**, after review and deliberation on the proposal, **LOUIE AND CHIT RESTAURANT AND EVENT CENTER** complied with the requirements and declared as the Single Calculated and Responsive Quotation (SCRQ);

**NOW, THEREFORE**, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **LOUIE AND CHIT RESTAURANT AND EVENT CENTER** in the amount of **TWO HUNDRED FORTY THOUSAND PESOS (Php240,000.00)**.




