RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO GOD'S TREASURE ENTERPRISES FOR THE PROCUREMENT OF CATERING SERVICES FOR THE DEPED 4A FOR YOU SEASON 5 PRODUCTION

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of CATERING SERVICES for the DEPED 4A FOR YOU SEASON 5 PRODUCTION on FEBRUARY 26, 2024, APRIL 24, 2024, JUNE 26, 2024, AUGUST 28, 2024, OCTOBER 30, 2024 AND DECEMBER 18, 2024;

WHEREAS, the Approved Budget for the Contract (ABC) is SEVENTY-TWO THOUSAND PESOS (Php72,000.00);

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on February 5, 2024 to February 12, 2024 at 9:00 a.m.;

WHEREAS, RFQs were sent to four (4) prospective suppliers as follows: (1) GOD'S TREASURE ENTERPRISES; (2) FOCAL MANAGING LOOP INC.; (3) JIVIC CATERING SERVICES; and (4) MEYER'S FOOD AND SERVICES, INC.;

WHEREAS, one (1) Supplier submitted its proposal: GOD'S TREASURE ENTERPRISES in the amount of SEVENTY THOUSAND TWO HUNDRED PESOS (Php70,200.00). Thus, GOD'S TREASURE ENTERPRISES is declared as the lone

WHEREAS, after review and deliberation on the proposal, GOD'S TREASURE ENTERPRISES complied with the requirements and declared as the Single Calculated and Responsive Bid (SCRB);

NOW, THEREFORE, the BAC hereby RESOLVES as it hereby RESOLVED to RECOMMEND to the Regional Director, as the Head of the Procuring Entity, the award of the project to GOD'S TREASURE ENTERPRISES in the amount of SEVENTY THOUSAND TWO HUNDRED PESOS (Php70,200.00).
