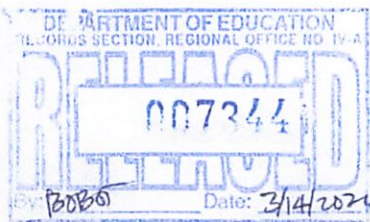

1. In reference to DepEd Order No. 83, s. 2012 Implementing Guidelines on Revised School-Based Management. (SBM) Framework, Assessment Process and Tool (APAT) and DepEd Order No. 75 s. 2022, Moratorium on the Conduct of School-Based Management Validation Activities, the Field Technical Assistance Division (FTAD) will conduct a Workshop on the Reconfiguration of the Validation Mechanism on School-Based Management Level III Practice on April 16-17, 2024, at 8:00 am. The venue for this activity will be announced through an Advisory.
2. The activity aims to:
  - a. identify significant accomplishments of the school in school management and efficient utilization of resources;
  - b. recognize innovations of the school that contribute to the seamless operations of the schools;
