**DESIGN AND DEVELOPMENT OF A PROGRAM FOR
INTERNATIONAL STUDENT ASSESSMENT
(PISA)-LIKE ASSESSMENT TOOL FOR
THE MATATAG CURRICULUM
(KEY STAGES 2 AND 3)**

To: **Schools Division Superintendents**

1. In line with DepEd Order No. 8. s. 2015 “Policy Guidelines on Classroom Assessment for the K to 12 Basic Education Program” and MATATAG Agenda which focuses on “MAke the curriculum relevant to produce competent and job-ready, active, and responsible citizens”, specifically number 9, which focuses on sharing test assessment with schools and teachers to strengthen the use of assessment, this Office, through the Curriculum and Learning Management Division (CLMD), announces the conduct of the above-mentioned activities from April 10 to 12, 2024 (on-line via Google Meet from 8:00 AM to 5:00 PM), and August 27 to 30, 2024 at a venue to be announced through an advisory.
2. This activity aims to design and develop a Regional Framework for Assessment and Contextualized Assessment Tool for Key Stages 2 and 3 anchored in the MATATAG Curriculum focusing on Reading, Science, and Mathematics. Through the developed assessment framework, the educational goals and objectives can be conceptualized including the process of its delivery and its refinement towards an established system of assessment. This activity ensures that the assessment tool and mechanism are aligned with the present MATATAG Curriculum on which the current education system is anchored. In addition, the developed output of this activity will help in understanding and becoming acquainted with the PISA question format to which the results are being used as a baseline for learners’ quality performance.
3. Participants are advised to bring their laptops during Phases 3 and 4 of the activity. In addition, they are expected to arrive at the venue before each activity commences at 8:00 AM on Day 1.
