To **Schools Division Superintendents**

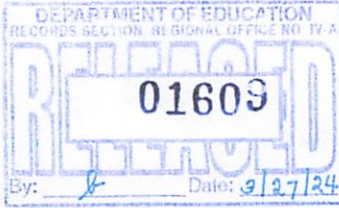

**ADDENDUM TO REGIONAL MEMORANDUM NO. 157 S. 2024:  
ENHANCED DETAILS FOR THE 2024 REGIONAL ATHLETIC  
ASSOCIATION MEET**

To: **Schools Division Superintendents**

1. This addendum supplements Regional Memorandum No. 157, 2024, concerning The 2024 Regional Athletic Association Meet: Scheduling and Preliminary Details with this year's theme: "Beyond Sports."
2. It provides further details on the Regional Athletic Association's organizational structure, event schedules, coach allocation, an indicative program of activities, billing, and playing, and an attached list of technical officials.
3. It is reminded that the Refresher course and Solidarity Meeting are scheduled for April 5-6, 2024, to be held at San Pedro Relocation Center National High School, San Pedro City. The Tournament Managers/Coordinators and Technical Officials attending the Solidarity Meeting must register and submit a Medical Certificate signed by a government physician. Also, on this day, April 6, 2024, all committee members are expected to be present to coordinate tasks properly and smoothly.
4. On the other hand, the billiards, Softball, and Baseball games will have their virtual meeting for this purpose on March 27, 2024, from 1:00 PM to 4:00 PM.
5. Members of the different Working Committees and Technical Officials from SDOs shall have food and a billeting quarter where their delegations are.
6. The working committees from the Regional Offices shall have food and a billeting quarter at Mater Ecclesia School at Mater Ecclesiae St., Barangay Maharlika, San Pedro City, Laguna.
7. All delegation members, including the Regional TWG, must bring their mattresses and beddings.
8. The Working Committees, Coaches, Assistant coaches, chaperons, trainers, delegation members, and technical officials who will render services during weekends and holidays shall be given Service Credits and Compensatory Overtime Credits (COC) for the non-teaching personnel and for employees

under Contract of Service (COS) based on the actual services rendered before and during the 2024 Regional Athletics Association Meet.

9. Travel expenses of the working committee members, Technical Officials, all members of the committee, and their management working committees may be given additional supplemental assistance on top of the allowable expenses to be given as may be authorized, shall be charged against local funds, subject to the usual accounting and auditing rules and regulations.
10. All team sports to be played in the 2024 Regional Athletic Association Meet shall adopt the "Play All" rule, which allows all team members to participate and play in their respective events.
