## Methodology of the Survey

### 1. Questionnaire for Parents and Learners:

- a. The SBFP EFS Survey Questionnaire for Learner beneficiaries and Parents/Guardians is conducted via Microsoft forms and can be accessed through these links.

Parents/Guardians: <https://forms.office.com/r/skwmDbVyky>
- b. The SDO Focal Person shall choose the participating schools to answer the EFS for the learner-beneficiaries and the parents or guardians.
- c. The participants of the survey must cover at least 25% of the SBFP Recipient schools in every SDO
- d. The participating schools shall constitute 50% of highly urbanized areas, and 50% of rural areas that have internet connectivity.
- e. At least 5-10% of SBFP learner beneficiaries (Kinder to Grades 6) and their parents/guardians per selected participating schools shall answer the online survey form.
- f. The SDO Focal Person shall send the link to the School Heads, who shall send it to Class Advisers, who shall be responsible for sharing it to selected learner beneficiaries and parents/guardians.
- g. The link will be sent via email or Facebook messenger group chat.

### 2. Questionnaire for School Head:

- a. The SBFP EFS Survey Questionnaire for School Head is conducted via Microsoft forms and can be accessed through this link: <https://forms.office.com/r/RUvxGAUc2s>
- b. The SDO Focal Person shall choose the participating schools to answer the EFS for the school head
- c. The participants of the survey must cover at least 50% of the SBFP Recipient schools in every SDO
- d. The participating schools shall constitute 50% of highly urbanized areas, and 50% of rural areas that have internet connectivity.
- e. The SDO Focal Person shall send the link to the School Heads and the link will be sent via email or Facebook messenger group chat.

The survey questionnaires shall be open for administration from **April 15-30, 2024**.
