WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of CATERING SERVICES for the QUARTERLY PROGRAM IMPLEMENTATION REVIEW AND PLAN ADJUSTMENT (PIRPA) on APRIL 19, 2024, JULY 23, 2024, OCTOBER 15, 2024 AND DECEMBER 23, 2024;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on February 14, 2024 to February 20, 2024 at 9:00 a.m.:
