Greetings from the National Nutrition Council (NNC) – CALABARZON!

This refers to this year's 50th Nutrition Month (NM) celebration with the theme: *"Sa PPAN: Sama-sama sa Nutrisyong Sapat Para sa Lahat"* (Through PPAN, let's collaborate on nutrition security for all!). The theme focuses on the national nutrition plan as the framework for nutrition action by stakeholders anchored on a theory of change and calls for widest dissemination at all levels. Further, the theme was realized in response to the finding that the Philippine Plan of Action for Nutrition (PPAN) has low awareness especially at the barangay level.


Hence, Nutrition Month which seems to be the most popular activity in nutrition among local government units, the campaign calls for the full adoption of the PPAN in local nutrition action plans. Likewise, the celebration aims to increase awareness and generate participation and commitments for increased support for the PPAN among stakeholders from **government, non-government organizations**, business, civil society, and communities. By calling for collective action in implementing the PPAN, all forms of malnutrition are reduced if not fully eradicated, with the end goal of ensuring nutrition security for all Filipinos.

Relative to this, the NNC calls on **all our regional line agencies (RLAs)** to embrace the theme of *"Sa PPAN: Sama-sama sa Nutrisyong Sapat Para sa Lahat"* and actively participate in Nutrition Month celebration come July 1, 2024, onwards. We are then requesting the respective Regional Sub-Committee on Nutrition (RSCN) member agencies to plan your activities for the 2024 Nutrition Month celebration and submit to us through our email address region4a@nnc.gov.ph on or before 14 June 2024 (Friday). NNC Calabarzon will be submitting the regional NM plans including the RLA plans to NNC Central Office (CO) by 21 June 2024 (Friday).

We are still awaiting the release of the NM Talking points from NNC CO, and we will gladly share it with you once available. Attached is the 2024 NM Plan template for your reference.
