## BAC RESOLUTION

RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO COUNTRY BANKERS INSURANCE CORPORATION FOR THE PROCUREMENT OF ACCIDENT INSURANCE FOR THE 2024 NATIONAL FESTIVAL OF TALENTS

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of ACCIDENT INSURANCE FOR THE 2024 NATIONAL FESTIVAL OF TALENTS on JULY 7-12, 2024;

WHEREAS, the Approved Budget for the Contract (ABC) is TWENTY-ONE THOUSAND TWO HUNDRED PESOS (Php21,200.00);

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the office website and conspicuous bulletin board in the premises of this Office starting on May 9, 2024 to May 14, 2024 at 9:00 a.m.;

WHEREAS, RFQs were sent to at least three (3) prospective suppliers as follows: (1) Country Bankers Insurance Corporation; (2) AXA Philippines; and (3) Pru Life UK;

WHEREAS, one (1) Supplier submitted its proposal: COUNTRY BANKERS INSURANCE CORPORATION in the amount of TWENTY-ONE THOUSAND TWO HUNDRED PESOS (Php21,200.00). Thus, COUNTRY BANKERS INSURANCE CORPORATION is declared as the lone bidder;

WHEREAS, after review and deliberation on the proposal, COUNTRY BANKERS INSURANCE CORPORATION complied with the requirements and declared as the Single Calculated and Responsive Quotation (SCRQ);

NOW, THEREFORE, the BAC hereby RESOLVES as it hereby RESOLVED to RECOMMEND to the Regional Director, as the Head of the Procuring Entity, the award of the project to COUNTRY BANKERS INSURANCE CORPORATION in the amount of TWENTY-ONE THOUSAND TWO HUNDRED PESOS (Php21,200.00).
