RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO SUNRISE RIDGE CORPORATION (SOLESTE SUITES) FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE RECALIBRATION OF INDIVIDUAL PERFORMANCE AND COMMITMENT REVIEW (IPCR) FOR ADMINISTRATIVE SERVICES DIVISION PERSONNEL

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of FOOD AND ACCOMMODATION for the RECALIBRATION OF INDIVIDUAL PERFORMANCE AND COMMITMENT REVIEW (IPCR) FOR ADMINISTRATIVE SERVICES DIVISION PERSONNEL on JUNE 18-20, 2024;

WHEREAS, the Approved Budget for the Contract (ABC) is ONE HUNDRED SIXTY-TWO THOUSAND PESOS (Php162,000.00);

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Prourement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on May 20, 2024 to May 24, 2024 at 9:00 a.m.;

WHEREAS, RFQs were sent to at least three (3) prospective suppliers as follows: (1) Sunrise Ridge Corporation (Soleste Suites); (2) Red Hotel; and (3) Great Eastern Hotel, Inc.;

WHEREAS, two (2) suppliers submitted their respective proposals before the deadline for the submission of quotations, offering the following financial quotations, as read:
