



BAC RESOLUTION

RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO D'GREAT STALLION SECURITY AGENCY, INC. FOR THE PROCUREMENT OF SECURITY SERVICE FOR THE YEAR 2024 FOR RELC-NEAP MALVAR, BATANGAS

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **SECURITY SERVICE FOR THE YEAR 2024 FOR RELC-NEAP MALVAR, BATANGAS** from **JULY 1, 2024** to **DECEMBER 31, 2024**;

WHEREAS, the Approved Budget for the Contract (ABC) is **THREE HUNDRED EIGHTY-FOUR THOUSAND NINE HUNDRED TWENTY-ONE PESOS AND 24/100 (Php384,921.24)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPs), office website and conspicuous bulletin board in the premises of this Office starting on May 17, 2024 to May 23, 2024 at 9:00 a.m.;

WHEREAS, RFQs were sent to at least three (3) prospective suppliers as follows: (1) D'Great Stallion Security Agency, Inc.; (2) Ugnayan Security Agency, Inc.; and (3) Kings 2000 Security Services Corp.;

WHEREAS, three (3) suppliers submitted their respective proposals before the deadline for the submission of quotations, offering the following financial quotations, as read:




