Other information relevant to the activity indicated in RM 349 s. 2024 shall remain in effect.

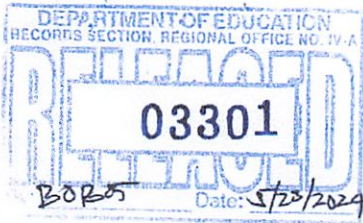
