To **Schools Division Superintendents**

1. With reference to the Joint Memorandum Circular No. 006, s. 2024 of the Department of Education, between the Office of the Undersecretary for Curriculum and Teaching and Office of the Undersecretary for Governance and Field Operations, the Bureau of Education Assessment conducted Capacity Building of Field Personnel on the Analysis and Utilization of the National Achievement Test (NAT) Results Phase 1 and 2 last November 13 to 17, 2023 and May 19 to 25, 2024. 
