

From the link above, it is required for you to use your DepEd email to download the information. Kindly select the excel sheet with list of Private Schools assigned on your region/school's division office. Then provide the following information on the last two column: **Latitude**¹ and **Longitude**².

The latitude and longitude can also be gathered using Google Maps, with the following steps in the link <https://bitly.cx/8vfr0>:

1. Open Google Maps.
2. Indicate the physical address from the search bar and press enter for the google map to locate.
3. After locating, right-click the place or area on the map.
 - This will open a pop-up window. You can find your latitude and longitude in decimal format at the top.
4. To copy the coordinates automatically, left click on the latitude and longitude.
 - The first decimal number is the latitude and the second is the longitude.

The purpose of the request is to map the private schools that will help decongest public junior high schools (JHS) and senior high schools (SHS) which one the GAS program objective stated in DepEd Order No. 20, s. 2017 for Educational Service Contracting Service (ESC) and DepEd Order No. 20, s. 2023 for Senior High School Voucher Program (SHS VP).

¹ Latitude specifies a location's distance north or south of the equator.

² Longitude specifies the location's distance east or west from an imaginary line connecting the North and South poles.

This refers to the request of the Government Assistance and Subsidies Service (GASS) to the Office of the Undersecretary for Operations to issue a memorandum to the Regional Directors (RDs) and Schools Division Superintendents (SDSs) to provide the global positioning system (GPS) coordinates of the private schools.

The purpose of the request is in line with the efforts of the GAS program to help decongest public junior high schools (JHS) and senior high schools (SHS) which one the program objective stated in DepEd Order No. 20, s. 2017 for Educational Service Contracting Service (ESC) and DepEd Order No. 20, s. 2023 for Senior High School Voucher Program (SHS VP).

After gathering the data from the Regions, GASS shall collaborate with EMISD on the integration of location data of both Private and Public schools to easily identify the distance between a public and private school (voucher participating school or non-voucher participating school) and provide solutions to reduce the classroom congested nationwide through the financial assistance provided by the GAS program.
