**BAC RESOLUTION**

**RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO SUNRISE RIDGE CORPORATION (SOLESTE SUITES) FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE VETTING AND FINALIZATION OF THE LEARNING RESOURCE PACKAGE FOR THE PREPARED PROGRAM**

**WHEREAS**, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **VETTING AND FINALIZATION OF THE LEARNING RESOURCE PACKAGE FOR THE PREPARED PROGRAM** on **AUGUST 14-16, 2024**;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **ONE HUNDRED TWENTY THOUSAND PESOS (Php120,000.00)**;

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS**, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on June 26, 2024 to July 1, 2024 at 9:00 a.m.;

**WHEREAS**, RFQs were sent to at least three (3) prospective suppliers as follows: (1) Sunrise Ridge Corporation (Soleste Suites); (2) Azteco Corporation (Axiaa Hotel); and (3) Camelot Hotel;

**WHEREAS**, one (1) Supplier submitted its proposal; **SUNRISE RIDGE CORPORATION (SOLESTE SUITES)** in the amount of **ONE HUNDRED FOURTEEN THOUSAND PESOS (Php114,000.00)**. Thus, **SUNRISE RIDGE CORPORATION (SOLESTE SUITES)** is declared as the lone bidder;

**WHEREAS**, after review and deliberation on the proposal, **SUNRISE RIDGE CORPORATION (SOLESTE SUITES)** complied with the requirements and declared as the Single Calculated and Responsive Quotation (SCRQ);

**NOW, THEREFORE**, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **SUNRISE RIDGE CORPORATION (SOLESTE SUITES)** in the amount **ONE HUNDRED FOURTEEN THOUSAND PESOS (Php114,000.00)**.


