## **BAC RESOLUTION**

RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO COUNTRY BANKERS INSURANCE CORPORATION FOR THE PROCUREMENT OF ACCIDENT INSURANCE FOR THE PARTICIPATION OF REGION IV-A CALABARZON TO THE 2024 PALARONG PAMBANSA

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of ACCIDENT INSURANCE for the PARTICIPATION OF REGION IV-A CALABARZON TO THE 2024 PALARONG PAMBANSA on JULY 3-17, 2024;

WHEREAS, the Approved Budget for the Contract (ABC) is **ONE HUNDRED TWENTY THOUSAND PESOS (Php120,000.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS,** the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office from June 26, 2024 to July 1, 2024 at 9:00 a.m.

**WHEREAS,** RFQs were sent to at least three (3) prospective suppliers as follows: (1) Country Bankers Insurance Corporation; (2) AXA Philippines; and (3) Pru Life UK;

WHEREAS, one (1) Supplier submitted its proposal; COUNTRY BANKERS INSURANCE CORPORATION in the amount of ONE HUNDRED TWENTY THOUSAND PESOS (Php120,000.00). Thus, COUNTRY BANKERS INSURANCE CORPORATION is declared as the lone bidder;

WHEREAS, after review and deliberation on the proposal, COUNTRY BANKERS INSURANCE CORPORATION complied with the requirements and declared as the Single Calculated and Responsive Quotation (SCRQ);

**NOW, THEREFORE**, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **COUNTRY BANKERS INSURANCE CORPORATION** in the amount **ONE HUNDRED TWENTY THOUSAND PESOS (Php120,000.00)**.
