RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO SUNNY GLADES PROPERTIES CORPORATION (TAGAYTAY HAVEN) FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE CONDUCT OF GROUPWORK MANAGEMENT OF LEARNER RIGHTS AND PROTECTION FOCAL PERSON

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **CONDUCT OF GROUPWORK MANAGEMENT OF LEARNER RIGHTS AND PROTECTION FOCAL PERSON** on **JUNE 27-28, 2024**;

WHEREAS, the Approved Budget for the Contract (ABC) is **ONE HUNDRED TWENTY THOUSAND PESOS (Php120,000.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on May 28, 2024 to June 3, 2024 at 9:00 a.m.;

WHEREAS, RFQs were sent to four (4) prospective suppliers as follows: (1) Sunny Glades Corp. (Tagaytay Haven Hotel); (2) Tagaytay Automart Inc. (Tagaytay Country Hotel); (3) Hotel Kimberly Tagaytay; and (4) Days Hotel Tagaytay;

WHEREAS, five (5) suppliers submitted their respective proposals before the deadline for the submission of quotations, offering the following financial quotations, as read:
