**EXTENSION OF APPLICATION OF SCHOOLS DIVISION OFFICES
OF DEPED REGION IV-A CALABARZON AS PROFESSIONAL
REGULATION COMMISSION – ACCREDITED CONTINUING
PROFESSIONAL DEVELOPMENT (CPD) PROVIDERS**

To **Schools Division Superintendents**

1. Relative to Regional Memorandum No. 330, s. 2024 titled, Application of the Schools Division Offices as PRC – Accredited Continuing Professional Development Providers, this Office through the Human Resource Development Division – National Educators’ Academy of the Philippines in the Region (NEAP-R) **announces the extension of application to PRC** as CPD providers until **August 9, 2024**.
2. For those SDOs who have already submitted their application to PRC, they must update the status of their application through this link: <https://bit.ly/IV-APRCApplicationTracker>.
3. All SDOs are expected to receive their accreditation as CPD Providers by September 30, 2024. Thus, the Regional Office will only process program applications from SDOs until this date.
4. All quality-assured PD Programs of the division-based, as well as school-based programs and activities, **must be processed by the division for accreditation starting October 1, 2024 – onwards**.
5. While waiting for the accreditation of SDOs as CPD Providers, all program applications prior to September 30, 2024, must be submitted through this link: <https://bit.ly/4ACPDProgramApplication>, and must be processed by the Regional Office. Consequently, the completion report of the programs facilitated by the Regional Office must be submitted via this link: <https://bit.ly/4ACPDCompletionReport>.
