**WHEREAS**, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **DESIGNING AND DEVELOPMENT FOR THE LEARNING RESOURCE PACKAGE FOR THE PREPARED PROGRAM** on **JULY 16-18, 2024**;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **ONE HUNDRED TWENTY THOUSAND PESOS (Php120,000.00)**;

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS**, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on June 26, 2024 to July 1, 2024 at 9:00 a.m.;

**WHEREAS**, RFQs were sent to at least three (3) prospective suppliers as follows: (1) Sunrise Ridge Corporation (Soleste Suites); (2) Azteco Corporation (Axiaa Hotel); and (3) Camelot Hotel;


