

## BAC RESOLUTION

RECOMMENDING THE APPROVAL OF THE AGENCY-TO-AGENCY AGREEMENT BETWEEN DEPED REGION IV-A CALABARZON AND DEVELOPMENT ACADEMY OF THE PHILIPPINES (DAP TAGAYTAY) FOR THE LEASE OF VENUE INCLUDING FOOD AND ACCOMMODATION FOR THE REGIONAL OFFICE-SCHOOLS DIVISION OFFICE BI-ANNUAL REGIONAL LEGAL EXECUTIVE COORDINATION MEETING (RELEXECOM)

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of LEASE OF VENUE INCLUDING FOOD AND ACCOMMODATION for the REGIONAL OFFICE-SCHOOLS DIVISION OFFICE BI-ANNUAL REGIONAL LEGAL EXECUTIVE COORDINATION MEETING (RELEXECOM) on JUNE 24-25, 2024;

WHEREAS, the Approved Budget for the Contract (ABC) is ONE HUNDRED FOUR THOUSAND SEVEN HUNDRED SIXTY PESOS (Php104,760.00);

WHEREAS, pursuant to the Consolidated Guidelines for the Alternative Methods of Procurement, Item V-D 9(b)(i) of Annex "H" in the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act No. 9184 states:

"i. Public-owned vis-a-vis privately-owned real property and venue.

It is preferred that government agencies lease publicly-owned real property or venue from other government agencies.

If there is an availbale publicy-owned real property or venue that complies with the requirements of the Procuring Entity, it may enter into a contract of lease with the government-agency owner.

In the event that the Procuring Entity would resort to privately-owned real property or venue, the End-User unit shall justify that the same is more efficient and economical to the government."

WHEREAS, pursuant to the Consolidated Guidelines for the Alternative Methods of Procurement, particularly paragraphs (b) and (c) of item V(D)(5), Annex "H" of the R-IRR of RA No. 9184 a Memorandum of Agreement may be entered into between the procuring entity and the servicing agency subject to the following conditions and process:

"b) Conditions. It is the general policy of the government to purchase its requirements from the private sector. However, it acknowledges that, in some exceptional cases, procurement from another agency of the government is more efficient and economical for the government, subject to the following conditions:

i. Servicing Agency has the mandate to deliver the goods and services required to be procured or to undertake the infrastructure project or consultancy required by the Procuring Agency" xxx



## c) Procedure

iv. In case of approval, the HOPE shall enter into a Memorandum of Agreement (MOA) with the Servicing Agency."

WHEREAS, the end-user, initiated the procurement activity by requesting for quotation to DEVELOPMENT ACADEMY OF THE PHILIPPINES (DAP TAGAYTAY).

WHEREAS, DEVELOPMENT ACADEMY OF THE PHILIPPINES (DAP TAGAYTAY) submitted its proposal in the amount of ONE HUNDRED FOUR THOUSAND SEVEN HUNDRED THIRTY-FIVE PESOS (Php104,735.00) and that it has the mandate to deliver the services required by said proposal as well as it owns the function rooms, guest rooms, food and beverage services and other facilities required for the event and that it complies with all the required general conditions as provided for in RA No. 9184 - Government Procurement Reform Act and its Implementing Guidelines under the Agency-to-Agency Agreements (Sec. 53.5);

NOW, THEREFORE, the BAC hereby RESOLVES as it hereby RESOLVED to RECOMMEND to the Regional Director, as the Head of the Procuring Entity, the award of the project via Negotiated Procurement (Agency-to-Agency) for the lease of venue including food and accommodation to DEVELOPMENT ACADEMY OF THE PHILIPPINES (DAP TAGAYTAY) in the amount of ONE HUNDRED FOUR THOUSAND SEVEN HUNDRED THIRTY-FIVE PESOS (Php104,735.00).
