WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of CATERING SERVICES for the SURVEILLANCE AUDIT ON QUALITY MANAGEMENT SYSTEM (QMS) CERTIFIABLE TO ISO 9001: 2015 STANDARDS on JUNE 13-14, 2024;

WHEREAS, RFQs were sent to three (3) prospective suppliers as follows: (1) God's Treasure Enterprises; (2) Focal Managing Loop Inc.; and (3) DepEd Region IV-A CALABARZON Multi-Purpose Cooperative;

WHEREAS, two (2) suppliers submitted their respective proposals before the deadline for the submission of quotations, offering the following financial quotations, as read:
