



Pursuant to DBM and COA Joint Circular No. 2019-1 dated January 1, 2019, on the "Updated Guidelines to Budget and Financial Accountability Reports (BFARs) Starting FY 2019", all agencies are mandated to regularly submit their Budget Accountability Report (BAR No. 1- Physical Report of Operation) to oversight agencies after the end of the quarter.
