**DISTRIBUTION, CIRCULATION, AND UTILIZATION
OF R4A MATATAG LEARNING OBJECTIVES GRID**

To **Schools Division Superintendents**

1. In support to the efficient implementation of the DepEd Order No. 10, s. 2024 titled Policy Guidelines in the Implementation of MATATAG Curriculum, this Office, through the Curriculum and Learning Management Division (CLMD), releases the R4A MATATAG Learning Objectives Grid (MLOG) for distribution, circulation, and utilization.
2. The R4A MLOG material is exclusively for teachers implementing the MATATAG K to 10 Curriculum. It aims to support the delivery of curriculum content, standards, and lesson competencies. It provides a structured framework to ensure that curriculum content, standards, and competencies are delivered effectively, fostering a cohesive and comprehensive educational experience for students. It primarily serves as an essential input for the design and development of learning plans.
3. Access links to the R4A MLOG files will be sent to the official e-mail address of Schools Division Offices (SDO) and Learning Resource Management Section (LRMS). Meanwhile, the utilization of the material shall be monitored by the Curriculum Implementation Division (CID). Moreover, the distribution and circulation of the said material shall be managed and monitored by the Division LRMS Education Program Supervisor (EPS).
4. The field implementers are hereby advised that the R4A MLOG shall not be modified, obliterated, reformatted, or repackaged, among others, in any manner. These changes include but are not limited to the removal of any part or pages and reducing or resizing that will affect the quality of the resource materials. Field Implementers are strictly reminded to observe DO 18, s. 2020 on the unauthorized printing, uploading, and sharing of digital files of the learning resource materials.
5. Teachers shall not be required to print or reproduce the R4A MLOG using their personal fund and resources. School heads are encouraged to optimize the utilization of the school MOOE for such purpose.




