TRAINING ON MENTAL HEALTH CRISIS MANAGEMENT AND REFERRAL MECHANISMS

To **Schools Division Superintendents**

1. Relative to the DM-OUOPS-2024-09-06086¹, The Bureau of Learner Support Services-School Health Division (BLSS-SHD) will conduct the Training on August 12-16, 2024, at the DepEd Ecotech Center in Cebu City. The Training aims to capacitate health personnel in responding to learners experiencing mental health crises.
2. The list of participants and the Memorandum above are attached. Travel and incidental expenses shall be charged to Sub-ARO OSEC-4A-24-2878 downloaded funds to the Schools Division, subject to the usual accounting and auditing rules and regulations. The Regional Office shall augment travel expenses to be charged to the School Mental Health Program fund.

Offices concerned are requested to grant compensatory time-off (CTO) to participating personnel, as applicable, computed against the actual days that they participate in the activity, in accordance with existing Civil Service Commission rules and regulations. Grant of CTO may apply to situations such as when personnel need to travel a day before the opening (Sunday) or a day after the closing (Saturday) due to the availability of flights or when a day or some days within the duration of the activity fall/s under (a) [local] holiday (s).
