WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **CATERING SERVICES** for the **2024 ANNUAL PHYSICAL AND LABORATORY EXAMINATION WITH VACCINATION OF DEPED REGIONAL EMPLOYEES** on **SEPTEMBER 6** and **13, 2024**;

WHEREAS, the Approved Budget for the Contract (ABC) is **SIXTY-NINE THOUSAND PESOS (Php69,000.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office from August 13, 2024 to August 19, 2024 at 9:00 a.m.;

WHEREAS, RFQs were sent to four (4) prospective suppliers as follows: (1) Focal Managing Loop Inc.; (2) DepEd Region IV-A CALABARZON Multi-Purpose Cooperative; (3) God's Treasure Enterprises; and (4) Meyer's Foods and Services, Inc;

WHEREAS, two (2) suppliers submitted their respective proposals before the deadline for the submission of quotations, offering the following financial quotations, as read:




