**WHEREAS**, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **ENHANCEMENT, QUALITY ASSURANCE, AND FINALIZATION OF LEARNING RESOURCE PACKAGE FOR FACILITATION SKILLS AND LEARNING MANAGEMENT TRAINING PROGRAM** on **SEPTEMBER 2-6, 2024**;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **ONE HUNDRED NINETY THOUSAND PESOS (Php190,000.00)**;

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS**, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office from August 6, 2024 to August 12, 2024 at 9:00 a.m.;

**WHEREAS**, RFQs were sent to at least three (3) prospective suppliers as follows: (1) Sunrise Ridge Corporation (Soleste Suites); (2) Caliv Resort and Development Corporation (Villa Excellence Beach and Wavepool Resort); and (3) The Bayleaf Hotel;

**WHEREAS**, four (4) suppliers submitted their respective proposals before the deadline for the submission of quotations, offering the following financial quotations, as read:
