BAC RESOLUTION

RECOMMENDING THE APPROVAL OF THE AGENCY-TO-AGENCY AGREEMENT BETWEEN DEPED REGION IV-A CALABARZON AND DEVELOPMENT ACADEMY OF THE PHILIPPINES (DAP TAGAYTAY) FOR THE LEASE OF VENUE INCLUDING FOOD AND ACCOMMODATION FOR THE REGION-BASED TRAINING OF SCHOOL HEADS ON INSTRUCTIONAL LEADERSHIP AND SUPERVISION OF MULTIGRADE SCHOOLS

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of LEASE OF VENUE INCLUDING FOOD AND ACCOMMODATION for the REGION-BASED TRAINING OF SCHOOL HEADS ON INSTRUCTIONAL LEADERSHIP AND SUPERVISION OF MULTIGRADE SCHOOLS on SEPTEMBER 9-13, 2024;

WHEREAS, the Approved Budget for the Contract (ABC) is FIVE HUNDRED TEN THOUSAND PESOS (Php510,000.00);

WHEREAS, pursuant to the Consolidated Guidelines for the Alternative Methods of Procurement, Item V-D 9(b)(i) of Annex "H" in the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act No. 9184 states:

"i. Public-owned vis-a-vis privately-owned real property and venue.

It is preferred that government agencies lease publicly-owned real property or venue from other government agencies.

If there is an availbale publicy-owned real property or venue that complies with the requirements of the Procuring Entity, it may enter into a contract of lease with the government-agency owner.

In the event that the Procuring Entity would resort to privately-owned real property or venue, the End-User unit shall justify that the same is more efficient and economical to the government."

WHEREAS, pursuant to the Consolidated Guidelines for the Alternative Methods of Procurement, particularly paragraphs (b) and (c) of item V(D)(5), Annex "H" of the R-IRR of RA No. 9184 a Memorandum of Agreement may be entered into between the procuring entity and the servicing agency subject to the following conditions and process:

"b) Conditions. It is the general policy of the government to purchase its requirements from the private sector. However, it acknowledges that, in some exceptional cases, procurement from another agency of the government is more efficient and economical for the government, subject to the following conditions:

i. Servicing Agency has the mandate to deliver the goods and services required to be procured or to undertake the infrastructure project or consultancy required by the Procuring Agency"

NOW, THEREFORE, the BAC hereby RESOLVES as it hereby RESOLVED to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project via Negotiated Procurement (Agency-to-Agency) for the lease of venue including food and accommodation to DEVELOPMENT ACADEMY OF THE PHILIPPINES (DAP TAGAYTAY) in the amount of FIVE HUNDRED NINE THOUSAND FIVE HUNDRED EIGHTY PESOS (Php509,580.00).
