BAC RESOLUTION

RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO GOD'S TREASURE ENTERPRISES FOR THE PROCUREMENT OF CATERING SERVICES FOR THE 3RD AND 4TH QUARTER DIVISION PROCESS REVIEW (DPR)

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **CATERING SERVICES** for the **3RD AND 4TH QUARTER DIVISION PROCESS REVIEW (DPR)** on **SEPTEMBER 3-5, 2024** and **NOVEMBER 6-8, 2024**;

WHEREAS, the Approved Budget for the Contract (ABC) is **SIXTY-ONE THOUSAND TWO HUNDRED PESOS (Php61,200.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on June 3, 2024 to June 7, 2024 at 9:00 a.m.;

WHEREAS, RFQs were sent to four (4) prospective suppliers as follows: (1) DepEd Region IV-A CALABARZON Multi-Purpose Cooperative; (2) Focal Managing Loop Inc.; (3) God's Treasure Enterprises; and (4) Meyer's Foods and Services, Inc.;

WHEREAS, one (1) Supplier submitted its proposal: **GOD'S TREASURE ENTERPRISES** in the amount of **FIFTY-NINE THOUSAND SIX HUNDRED SEVENTY PESOS (Php59,670.00)**. Thus, **GOD'S TREASURE ENTERPRISES** is declared as the lone bidder;

WHEREAS, after review and deliberation on the proposal, **GOD'S TREASURE ENTERPRISES** complied with the requirements and declared as the Single Calculated and Responsive Quotation (SCRQ);

NOW, THEREFORE, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **GOD'S TREASURE ENTERPRISES** in the amount of **FIFTY-NINE THOUSAND SIX HUNDRED SEVENTY PESOS (Php59,670.00)**.
