RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO DEPED REGION IV-A CALABARZON MULTIPURPOSE COOPERATIVE FOR THE PROCUREMENT OF CATERING SERVICES FOR THE CONDUCT OF BENCHMARKING ACTIVITIES ON KNOWLEDGE MANAGEMENT SYSTEM

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **CATERING SERVICES** for the **CONDUCT OF BENCHMARKING ACTIVITIES ON KNOWLEDGE MANAGEMENT SYSTEM** on **AUGUST 20, 2024**;

WHEREAS, the Approved Budget for the Contract (ABC) is **THIRTY-TWO THOUSAND FOUR HUNDRED PESOS (Php32,400.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the “Government Procurement Reform Act of 2003”, allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex “H” thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the office website and conspicuous bulletin board in the premises of this Office from August 8, 2024 to August 13, 2024 at 9:00 a.m.;

WHEREAS, RFQs were sent to four (4) prospective suppliers as follows: (1) DepEd Region IV-A CALABARZON Multi-Purpose Cooperative, Inc.; (2) Meyer’s Foods and Services; (3) Focal managing Loop Inc.; and (4) God’s Treasure Enterprises;

WHEREAS, one (1) Supplier submitted its proposal: **DEPED REGION IV-A CALABARZON MULTIPURPOSE COOPERATIVE** in the amount of **THIRTY-TWO THOUSAND FOUR HUNDRED PESOS (Php32,400.00)**. Thus, **DEPED REGION IV-A CALABARZON MULTIPURPOSE COOPERATIVE** is declared as the lone bidder;

WHEREAS, after review and deliberation on the proposal, **DEPED REGION IV-A CALABARZON MULTIPURPOSE COOPERATIVE** complied with the requirements and declared as the Single Calculated and Responsive Quotation (SCRQ);

NOW, THEREFORE, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **DEPED REGION IV-A CALABARZON MULTIPURPOSE COOPERATIVE** in the amount of **THIRTY-TWO THOUSAND FOUR HUNDRED PESOS (Php32,400.00)**.
