FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE PRE-CONSULTATION WORKSHOP FOR THE LOCALIZED REFERRAL SYSTEM ON MENTAL HEALTH PSYCHOSOCIAL SUPPORT (MHPSS) INTERVENTIONS AND ADOLESCENT REPRODUCTIVE HEALTH**

**WHEREAS**, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **PRE-CONSULTATION WORKSHOP FOR THE LOCALIZED REFERRAL SYSTEM ON MENTAL HEALTH PSYCHOSOCIAL SUPPORT (MHPSS) INTERVENTIONS AND ADOLESCENT REPRODUCTIVE HEALTH** on **SEPTEMBER 2-4, 2024**;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **TWO HUNDRED ELEVEN THOUSAND FIVE HUNDRED SIXTY-SIX PESOS (Php211,566.00)**;

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS**, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office from August 20, 2024 to August 26, 2024 at 9:00 a.m.;

**WHEREAS**, RFQs were sent to at least three (3) prospective suppliers as follows: (1) L&B International Tourist Hotel Inc. (Camelot Hotel); (2) Red Hotel; and (3) Sunrise Ridge Corporation (Soleste Suites);
