To: **All Schools Division Superintendents**

(Antipolo City, Batangas, Biñan City, Cabuyao City, Cavite Province, Dasmariñas City, Imus City, Gen. Trias City, Laguna Province, Lipa City, San Pedro City, Sta. Rosa City, Quezon Province and Rizal Province)

1. This refers to memorandum OUF-2024-0521 on the Request for Inquiry and Verification of ESC and SHS VP Program Beneficiaries with Learner Information System (LIS) Findings. The said activity shall be conducted on September 2-12, 2024.

 - a. conduct of an inquiry into the discrepancies identified by verifying the claims/allegations of the private schools that learners were enrolled in their schools during the time of billing against the statements to be gathered from the learners themselves, teachers, school's heads, schools division superintendents, and/or other concerned individuals; and
 - b. ascertain how the schools obtained the names and Learner Reference Number (LRNs) of the learners.
3. This activity is a joint inquiry and verification of the ESC and SHSVP Beneficiaries, hence, the SDO team shall be composed of either the SGOD Chief, EPS in-charge of Private Schools, Planning Officer and/or EPS in-charge of SHS. Moreso, the list of the RO Monitoring Officials and its corresponding SDO assignment and inclusive date/s of monitoring as per Enclosure 1.
