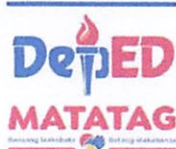

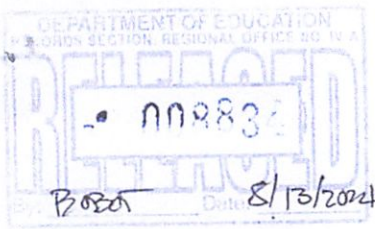

**ORIENTATION ON THE ALTERNATIVE DELIVERY MODE

To **Schools Division Superintendents**

1. This issuance refers to **DM-CT-2023-340** on the Orientation on the Alternative Delivery Mode Education in Emergencies (ADM-EiE) for School Leaders on **October 7-11, 2024**. Venue of the activity is to be announced through an advisory.
2. The activity aims to:
