Regional Memorandum No.487 s.2024

FINALIZATION OF THE GAWAD PATNUGOT AND GAWAD BITUIN GUIDELINES AND CRITERIA

- To Regional PRAISE Committee Schools Division Superintendents All Others Concerned
 - 1. With reference to DepEd Order No. 78, s. 2007, titled "Strengthening the Program on Awards and Incentives for Service Excellence (PRAISE) of the Department of Education," paragraph 4 states that the regional and division PRAISE committees shall formulate and establish their respective internal rules, policies, and procedures to govern the conduct of activities, which shall include the guidelines in evaluating the nominees and the mechanism for recognizing the awardees. In November 2023, the HRDD, in collaboration with the Regional PRAISE Committee spearheaded the review and enhancement of the guidelines and criteria to be used for the 10th Gawad Patnugot and Gawad Bituin. The finalization of these guidelines and criteria will be held on September 10-12, 2024, with venue to be determined.
 - 2. The activity aims the participants to:
 - a. revisit the reviewed and enhanced guidelines and criteria based on the gathered feedback from the panel.
 - b. integrate the comments and suggestions to finalize the criteria and guidelines; and
 - c. present the final guidelines and criteria, ready for implementation.
 - 3. The participants in this activity are the Regional Office PRAISE Committee members and those who attended the workshop in November 2023. Please refer to the attached list of attendees from 2023. They are also expected to prepare their draft outputs based on the categories they were assigned.
