REITERATION OF THE SUPPLEMENTARY GUIDELINES ON THE UTILIZATION OF TRANSITION LEARNING RESOURCES (LESSON EXEMPLARS AND WORKSHEETS) FOR THE IMPLEMENTATION OF THE MATATAG CURRICULUM

To **Schools Division Superintendents**

- In line with the Department of Education's Memorandum DM-CT-2024-296 dated August 16, 2024, the Regional Office hereby reiterates the supplementary guidelines on the utilization of transition Lesson Exemplars (LEs) and Learning Activity Sheets (LASs) in the implementation of the MATATAG Curriculum for Grades 1, 4, and 7, as specified in the attached Joint Memorandum issued on June 24, 2024.
- The following are the Key Points Emphasized:
 - 2.1. Definition of Terms:
 - Lesson Exemplar (LE):** A lesson teaching and learning plan with content and activities aligned with MATATAG curriculum standards to guide teachers in delivering the intended curriculum.
 - Learning Activity Sheet (LAS):** A learning resource that includes sets of exercises and assessments that complement the delivery of lesson exemplars.
 - Worksheet** will be renamed as Learning Activity Sheet.
 - 2.2. Non-Consumable Materials:
 - The LEs and LASs are non-consumable resources. Users are advised to use separate answer sheets or notebooks. Proper care and retrieval of these materials are essential for future use.
 - 2.3. Access and Distribution:
 - The OneDrive link for the digital files of LEs and LASs has been shared with Schools Division Offices and Public Schools. Teachers are encouraged to utilize these digital files.
 - 2.4. Regular Monitoring and Safeguarding:


