**WHEREAS**, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD WITH CONFERENCE HALL** for the **SCHOOL-BASED FEEDING PROGRAM (SBFP) SUPPLIERS AND PARTNERS FORUM** on **SEPTEMBER 27, 2024**;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **ONE HUNDRED SEVENTY-FOUR THOUSAND PESOS (Php174,000.00)**;

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS**, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office from August 28, 2024 to September 2, 2024 at 9:00 a.m.;

**WHEREAS**, RFQs were sent to four (4) prospective suppliers as follows: (1) Madison 101 Hotel; (2) Red Hotel; (3) BGISTS Development Corporation (Luxent Hotel); and (4) Axiaa Hotel;

**WHEREAS**, two (2) suppliers submitted their respective proposals before the deadline for the submission of quotations, offering the following financial quotations, as read:
