WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of FOOD AND ACCOMMODATION for the EVALUATION OF THE COMPLETED BASIC RESEARCH UNDER THE 9TH CYCLE BERF USING QUALITY CONTROL CHECKLIST on SEPTEMBER 2-4, 2024;

WHEREAS, the Approved Budget for the Contract (ABC) is **NINETY-SIX THOUSAND PESOS (Php96,000.00)**;

**WHEREAS,** Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS,** the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office from August 2, 2024 to August 8, 2024 at 9:00 a.m.;


