

## BAC RESOLUTION

RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO DRUGCHECK PHILIPPINES INC. FOR THE PROCUREMENT OF PHYSICAL EXAMINATION AND LABORATORY FOR THE 2024 ANNUAL PHYSICAL AND LABORATORY EXAMINATION WITH VACCINATION OF DEPED REGIONAL EMPLOYEES

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of PHYSICAL EXAMINATION AND LABORATORY for the 2024 ANNUAL PHYSICAL AND LABORATORY EXAMINATION WITH VACCINATION OF DEPED REGIONAL EMPLOYEES on SEPTEMBER 6, 13 and 20, 2024;

WHEREAS, the Approved Budget for the Contract (ABC) is THREE HUNDRED FORTY-EIGHT THOUSAND EIGHTY PESOS (Php348,080.00);

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on August 13, 2024 to August 19, 2024 at 9:00 a.m.;

WHEREAS, RFQs were sent to five (5) prospective suppliers as follows: (1) Drugcheck Philippines Inc.; (2) Accurate Health Medical Group (Heartland Medical and Diagnostic Center); (3) Healthline Medical Health Services; (4) Best Diagnostic Corporation; and (5) Prolab Diagnostis Co.;

WHEREAS, five (5) suppliers submitted their respective proposals before the deadline for the submission of quotations, offering the following financial bids, as read:


