BAC RESOLUTION

RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO MADISON 101 INC. (MADISON 101 HOTEL INC. + TOWER) FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE TRAINING WORKSHOP ON SYNCHRONIZED GAD PLANNING AND BUDGETING CUM PREPARATION OF GAD ACCOMPLISHMENT

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **TRAINING WORKSHOP ON SYNCHRONIZED GAD PLANNING AND BUDGETING CUM PREPARATION OF GAD ACCOMPLISHMENT** on **OCTOBER 2-4, 2024**;

WHEREAS, the Approved Budget for the Contract (ABC) is **THREE HUNDRED SIXTY THOUSAND PESOS (Php360,000.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on September 5, 2024 to September 10, 2024 at 9:00 a.m.;

WHEREAS, RFQs were sent to at least three (3) prospective suppliers as follows: (1) Tagaytay Automart Inc. (Tagaytay Country Hotel); (2) Madison 101 Inc. (Madison 101 Hotel Inc. + Tower); and (3) Sunrise Ridge Corporation (Soleste Suites);

WHEREAS, three (3) suppliers submitted their respective proposals before the deadline for the submission of quotations, offering the following financial quotations, as read:

reflected on the report, **GREAT EASTERN HOTEL, INC.** appears non-compliant for failure to comply with the specification as follows:

- a. Internet connection in the function halls and rooms is poor or weak. It ranges from 17.6 to 18.0 mpbs only which is below the set internet speed of at least 40 mbps. There is a need for a strong connection since most of the outputs are to be accomplished and submitted online. Please see the attached screenshot of the speed test;
- b. The function rooms/halls are not well-lit;

WHEREAS, on September 16, 2024, the end-user conducted an ocular inspection at **MADISON 101 INC. (MADISON 101 HOTEL INC. + TOWER)**, rated the venue in accordance with the technical specification issued by this office;

WHEREAS, after review and deliberation on the proposal, **MADISON 101 INC. (MADISON 101 HOTEL INC. + TOWER)** complied with the requirements and declared as the Lowest Calculated and Responsive Quotation (LCRQ);

NOW, THEREFORE, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED**:

1. To **DECLARE GREAT EASTERN HOTEL, INC.** as ineligible bidders for failure to comply the specification of this office.
2. To **DECLARE MADISON 101 INC. (MADISON 101 HOTEL INC. + TOWER)** as the bidder having the Lowest Calculated and Responsive Quotation (LCRQ).
3. To **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **MADISON 101 INC. (MADISON 101 HOTEL INC. + TOWER)** in the amount **THREE HUNDRED FORTY-ONE THOUSAND ONE HUNDRED PESOS (Php341,100.00)**.
